Gloria Martinez is the Strategic Services Manager for Public Works, City of Frisco. She has committed more than 20+ years in government service starting with the California Highway Patrol and started her tenure with the City of Frisco in 2008. Prior to her current position, she was an Engineering Administrative Assistant and Senior Human Resources Generalist.

Gloria leads the Administrative and Customer Service Divisions of Public Works, consisting of two supervisors, four customer service representatives, three administrative specialists, and a support services coordinator. She and her team support more than 240 men and women, operating and maintaining the Frisco Public Works infrastructure including Water Utilities (water, sewer, and reuse), Storm-

water utility, Streets, Traffic Operations and the Right of Way Divisions. She is the catalyst for the Department's many successes: maintaining APWA Accreditation, processing annual budget documents, supporting numerous disaster events, leading National Public Works Week planning, innovating many technology ideas and much more.

Last year she graduated from Class 4 of the Public Works Institute of Texas (PWITX) and afterwards was selected to join the PWITX Committee for her strong administrative and visionary leadership abilities. Gloria is actively engaged in many professional affiliations including APWA, AWWA, Society for Human Resources Management (SHRM) and the Texas Municipal Leagues' Association of

Hispanic Municipal Officials.

Her support to APWA and the Texas Chapter & Branch is considerable. For two consecutive years Gloria has been on the local and state planning committees for the Annual Chapter Conferences. This year she joins the APWA National Committee for Diversity, Equity and Inclusion. Gloria was a key member of the Frisco Public Works Department's Committee, leading to national accreditation in 2019 and now serves as the APWA City of Frisco Public Works Accreditation Manager.
